- 10 WHEREAS, The cost is \$7,500.00 for 6 stations at \$1,250.00 per
- 11 station plus \$500.00 for contingency funds.

- 13 THEREFORE IT BE RESOLVED that the LSU Student Senate allocate a
- 14 maximum of \$8,000.00 from the Surplus account to fund 6 water bottle refill
- 15 stations.

- 18 allocation of funds has until June 30, 2022, the end of the fiscal year, to be
