**A Resolution**

*To Urge and Request LSU to extend Concentrated Study Period, also known as "Dead Week," from five (5) days to seven (7) days to now begin on Monday instead of Wednesday.*

- 1 WHEREAS, dead week currently begins on a Wednesday;-and
- 2 WHEREAS, that leaves space for large assignments and exams to be
- 3 due that Monday and Tuesday; and
- 4 WHEREAS, this causes stress during the Fall Semester and over
- 5 Thanksgiving Break; and
- 6 WHEREAS, concentrated study period has turned into a way for
- 7 professors to overload students with last minute assignments; and
- 8 WHEREAS, by altering the dates, students are given a whole week to
- 9 prep for finals week without the possibility of another exam or
- 10 assignment that should not be within a week of a final; and
- 11 WHEREAS, this is an effective way to ensure students go into finals
- 12 week with as little stress as possible.

- 15 UNIVERSITY STUDENT SENATE, that Student Government requests
- 16 LSU to extend the Concentrated Study Period to begin on a Monday.
