A Resolution

To Urge and Request LSU to require all make up Saturday classes to be asynchronous


- 1 WHEREAS, the last three semesters, LSU has had to implement make up
- 2 days following PS 117; and
- 3 WHEREAS the last time this policy was revised was in 2016; and
- 4 WHEREAS, since then, LSU has become more technologically inept in lieu
- 5 of the Pandemic; and
- 6 WHEREAS, according to PS 117, once even two class days have been
- 7 interrupted, LSU must either implement Saturday classes or
- 8 cancel/shorten a break; and
- 9 WHEREAS, many students have work or other obligations on the
- 10 weekends; and
- 11 WHEREAS, having make up days be asynchronous relives stress from the
- 12 student if they must miss; and
- 13 WHEREAS, many professors already have most of their class notes
- 14 available to post online; and
- 15 WHEREAS, this would give students the opportunity to catch in their
- 16 classes on their own time outside of their obligations; and
- 17 WHEREAS, this would allow a stress-free continuation of Saturday
- 18 classes, when needed, for both students and Faculty; and

- 20 THEREFORE BE IT RESOLVED BY THE LOUISIANA STATE
- 21 UNIVERSITY STUDENT SENATE, that Student Government requests
- 22 LSU to mandate that if a Saturday make up class occurs; it must be
- 23 asynchronous.

 29 THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE by a simple
 30 majority (one-half plus one) vote of the LSU Student Senate and signature
 31 by the Student Body President, upon lapse of time for presidential action,
 32 or if vetoed by the President and subsequently approved by the Senate, on
 33 the date of such approval.
