### A Resolution

*To urge and request Louisiana State University to issue an official public statement regarding their plans for carceral labor to not return to the A&M Campus*

- 1 WHEREAS, carceral labor was prevalent on the A&M campus until its suspension
- 2 during the COVID-19 pandemic, AND;
- 3 WHEREAS, many students have raised questions and concerns about the use of
- 4 carceral labor on campus, AND;
- 5 WHEREAS, those performing carceral labor are paid paltry wages, amounting to
- 6 mere cents per hour, AND;
- 7 WHEREAS, Facilities Services has stated to the authors that there are no plans for
- 8 carceral labor to return to campus, AND;
- 9 THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE
- 10 UNIVERSITY STUDENT SENATE that Student Government urges and
- 11 requests the university to issue an official public statement indicating that
- 12 carceral labor will not be returning after its COVID-19 pandemic-induced
- 13 hiatus.

14 BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE  
 15 SUBMITTED TO Tony Lombardo, Associate Vice President of Facility &  
 16 Property Oversight and Tammy Millican, Executive Director of Facility &  
 17 Property Oversight.

18 THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE by a simple  
 19 majority (one-half plus one) vote of the LSU Student Senate and signature by  
 20 the Student Body President, upon lapse of time for presidential action, or if  
 21 vetoed by the President and subsequently approved by the Senate, on the date  
 22 of such approval.
