#### A Bill

To appropriate \$2000 for the purchase of 8 boxes (1 cubic foot each) of biodegradable confetti and 8 orders of glassine bags (300 each) to be handed out to graduates from the Student Government office for the Fall 2022 commencement.

1 WHEREAS, nonbiodegradable confetti has been a problem  
2 on campus within recent years being used in places such as  
3 Mike's habitat and Tower Drive.

4  
5 WHEREAS, the cleanup for nonbiodegradable confetti can  
6 be time-consuming and tedious as well as cause harm to  
7 Mike the Tiger if ingested.

8  
9 WHEREAS, this bill would allocate funds to purchase 8  
10 cubic foot boxes of dandelion and grape confetti and 8  
11 orders of 300 biodegradable glassine bags to be filled and  
12 handed out in the Student Government Office, 2,400  
13 glassine bags total.

15 WHEREAS, these bags will be filled by volunteers from  
16 either the Executive, Legislative, or Judicial branch.

17  
18 WHEREAS, graduating seniors and graduating graduate  
19 students will fill out a Tigerlink checkout and show the  
20 desk worker to claim up to 2 bags of biodegradable  
21 confetti.



29 bags.



34 TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY  
35 THE PRESIDENT AND SUBSEQUENTLY APPROVED BY  
36 THE SENATE, ON THE DATE OF SUCH APPROVAL.
