Consideration of Legislation to change Presentation Rights of
Lead Authors

Enacted,

1 Original Text:

2 1 No committee of the Senate shall consider legislation
3 without the author present, unless the Speaker directs the
4 committee otherwise. The author of the legislation shall be
5 recognized in opening comments followed by questions. Any
6 member of the committee may be recognized for debate
7 following questions for the author. Once debate has ended or
8 there is a motion for previous question, the author shall give
9 closing comments. The committee will proceed with a roll
10 call vote.

11 Amended Text:

12 § 606. Consideration of legislation

13 1 No committee of the Senate shall consider legislation
14 without the author or the author's approved proxy present,
15 unless the author has given written permission for the
16 committee to hear the legislation without the author or the
17 author's proxy present, unless the Speaker directs the
18 committee otherwise. The author of the legislation shall be
19 recognized in opening comments followed by questions. Any
20 member of the committee may be recognized for debate




