29 the ballot; and


30 WHEREAS, the writers decided to remove having to provide

35 WHEREAS, this bill removes Title VI Chapter 3 Section 212  
36 number 7 of the Student Government Code and renumbers  
37 the remaining numbers accordingly; and

38 THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A  
39 TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE  
40 AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF  
41 TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY  
42 THE PRESIDENT AND SUBSEQUENTLY APPROVED BY  
43 THE SENATE, ON THE DATE OF SUCH APPROVAL.
