**A FINANCE BILL**

**TO ALLOCATE A MAXIMUM OF THREE THOUSAND EIGHT HUNDRED FIFTY DOLLARS AND ZERO CENTS (\$3,850.00) FROM THE STUDENT GOVERNMENT LEGISLATIVE INITIATIVE ACCOUNT TO FUND AN IRRIGATION SYSTEM AND ROSES IN FRONT OF A LOUISIANA STATE UNIVERSITY SIGN**

**PARAGRAPH 1:** WHEREAS, THE LOUISIANA STATE UNIVERSITY SIGN AT THE DALRYMPLE ROUNDABOUT IS CURRENTLY OCCUPIED BY WEEDS AND VARIOUS SHRUBBERY; AND

**PARAGRAPH 2:** WHEREAS, THE PURPLE AND GOLD ROSES WOULD ENHANCE THE VISUAL QUALITY OF THE ROUNDABOUT AS WELL AS THE PHYSICAL APPEARANCE OF THE CAMPUS; AND

**PARAGRAPH 3:** WHEREAS, MANY POTENTIAL, CURRENT, AND FORMER LOUISIANA STATE UNIVERSITY STUDENTS, FACULTY, AND VISITORS PASS THIS SIGN ON A DAILY BASIS; AND

**PARAGRAPH 4:** WHEREAS, IN ORDER TO MAINTAIN THE FLOWERS, THE PURCHASE AND INSTALLATION OF A QUALITY IRRIGATION SYSTEM IS NECESSARY; AND

**PARAGRAPH 5:** WHEREAS, THE FUNDS SHALL BE ALLOCATED AS FOLLOWS:

1. ROSES (\$1,100)
2. IRRIGATION SYSTEM (\$2,750)

**PARAGRAPH 6:** THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT A MAXIMUM OF THREE THOUSAND EIGHT HUNDRED FIFTY DOLLARS AND ZERO CENTS (\$3,850) FROM THE STUDENT GOVERNMENT LEGISLATIVE CONTINGENCY ACCOUNT BE ALLOCATED TO FUND AN IRRIGATION SYSTEM AND ROSES IN FRONT OF A LOUISIANA STATE UNIVERSITY SIGN, AND

**PARAGRAPH 7:** BE IT FURTHER RESOLVED THAT A COPY OF THIS BILL BE TRANSMITTED TO ALISA JONES, STUDENT GOVERNMENT FINANCIAL COORDINATOR, AND

TAMMY MILLICAN, ASSISTANT DIRECTOR OF FACILITY SERVICES.

**PARAGRAPH 8:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS ( $2/3$ ) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
