10 **TO ALLOCATE A MAXIMUM OF THREE THOUSAND ONE HUNDRED SEVENTEEN DOLLARS**
11 **(\$2,697.00) FROM THE LEGISLATIVE GENERAL CONTINGENCY ACCOUNT TO FUND**
12 **THREE (3) STUDENTS TO ATTEND THE NATIONAL BLACK ASSOCIATION FOR SPEECH-**
13 **LANGUAGE AND HEARING CONVENTION**

15 **PARAGRAPH 1:** WHEREAS, THESE STUDENTS ARE MEMBERS OF THE NATIONAL
16 STUDENT SPEECH-LANGUAGE HEARING ASSOCIATION
17 RECOGNIZED BY CAMPUS LIFE AT LOUISIANA STATE UNIVERSITY;

20 **PARAGRAPH 2:** WHEREAS, THESE STUDENTS ARE ATTENDING THE CONFERENCE
21 TO RECRUIT STUDENTS FROM UNDER-REPRESENTED
22 POPULATIONS TO THE GRADUATE SCHOOL; AND

24 **PARAGRAPH 3:** WHEREAS, ONE OF THE FOUR GOALS OUTLINED BY THE LSU
25 FLAGSHIP 2020 MISSION STATEMENT IS TO “STRENGTHEN THE
26 INTELLECTUAL ENVIRONMENT BY BROADCASTING THE CULTURAL
27 DIVERSITY OF THE LSU COMMUNITY;” AND

29 **PARAGRAPH 4:** WHEREAS, INCREASED DIVERSITY WITH SPEECH-LANGUAGE
30 PATHOLOGY AND AUDIOLOGY ALIGN WITH THE NATIONAL
31 GOVERNING BODY OF SPEECH-LANGUAGE PATHOLOGISTS, THE
32 AMERICAN SPEECH-LANGUAGE HEARING ASSOCIATION; AND
