9 **A FINANCE BILL**

10 **TO ALLOCATE A MAXIMUM OF SEVEN HUNDRED DOLLARS AND ZERO CENTS (\$700.00)**
11 **FROM THE STUDENT GOVERNMENT LEGISLATIVE CONTINGENCY ACCOUNT TO FUND**
12 **ONE (1) MOBILE DEVICE CHARGING STATION FOR THE BUSINESS EDUCATION COMPLEX**
13 **(BEC)**

15 **PARAGRAPH 1:** WHEREAS, THE BUSINESS EDUCATION COMPLEX IS A HIGH
16 TRAFFIC AREA FOR STUDENTS OF ALL MAJORS; AND

18 **PARAGRAPH 2:** WHEREAS, FUNDING A CHARGING STATION TO BE INSTALLED IN
19 THE BEC WILL PROVIDE STUDENTS WITH A FREE AND EASY
20 OPPORTUNITY TO KEEP THEIR MOBILE DEVICES CHARGED AT
21 THEIR CONVENIENCE; AND

23 **PARAGRAPH 3:** WHEREAS, THE STUDENT WORKERS OF THE BEC HAVE AGREED
24 TO TAKE ON THE RESPONSIBILITY OF OVERLOOKING THE
25 CHARGING STATION DURING DAILY BUSINESS HOURS; AND

27 **PARAGRAPH 4:** WHEREAS, IN ORDER TO MAINTAIN THE UPKEEP OF THE
28 CHARGING STATION THE BEC HAS AGREED TO ONLY MAKE THEM
29 AVAILABLE DURING BUSINESS HOURS; AND

31 **PARAGRAPH 5:** WHEREAS, THE BUDGET OF THE CHARGING STATION IS AS
32 FOLLOWS:

36 TOTAL COST: \$700.00



38 **PARAGRAPH 6:** THEREFORE, BE IT ENACTED BY THE LOUISIANA
39 STATE UNIVERSITY STUDENT SENATE THAT SEVEN
40 HUNDRED DOLLARS AND ZERO CENTS (\$700) BE ALLOCATED FROM
41 THE SG LEGISLATIVE CONTINGENCY ACCOUNT TO FUND ONE
42 MOBILE DEVICE CHARGING STATION TO BE LOCATED IN THE
43 BUSINESS EDUCATION COMPLEX, AND

45 **PARAGRAPH 7:** BE IT FURTHER RESOLVED THAT A COPY OF THIS BILL
46 BE TRANSMITTED TO Ms ALISA JONES, THE STUDENT
47 GOVERNMENT FINANCIAL COORDINATOR.

49 **PARAGRAPH 8:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS
50 (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY
51 THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL
52 ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY
53 APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
