A RESOLUTION

TO URGE AND REQUEST ONE BUS BE ADDED TO THE TIGER TRAILS PURPLE BUS ROUTE.

PARAGRAPH 1: WHEREAS, THE PURPLE AND GOLD TIGER TRAILS BUSES ON THE LSU CAMPUS CURRENTLY SERVE THE SAME ROUTE IN OPPOSING DIRECTIONS; AND

PARAGRAPH 2: WHEREAS, THERE ARE CURRENTLY TWO GOLD BUSES AND ONLY ONE PURPLE BUS TO SERVE STUDENTS; AND

PARAGRAPH 3: WHEREAS, THE CURRENT GOLD BUS ROUTE IS MORE ACCESSIBLE TO STUDENTS LOCATED ON THE SOUTH SIDE OF CAMPUS AND THE CURRENT PURPLE BUS ROUTE IS MORE ACCESSIBLE TO STUDENTS LOCATED ON THE NORTH SIDE OF CAMPUS; AND

PARAGRAPH 4: WHEREAS, THERE IS CURRENTLY EXCESSIVE OCCUPANCY ON THESE THREE BUSES IN THE MIDDLE OF THE DAY; AND

PARAGRAPH 5: THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE ONE BUS BE ADDED TO THE TIGER TRAILS PURPLE BUS ROUTE FROM THE HOURS OF 11:00AM TO 1:00PM MONDAY THROUGH FRIDAY FROM THE STAND-BY BUS SUPPLY.

PARAGRAPH 6: BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO JASON BADEAUX, STUDENT BODY PRESIDENT, MICHELLE LOWRY, LEGISLATIVE BRANCH ADVISOR, RENE PETIT, STUDENT GOVERNMENT DIRECTOR OF TRANSPORTATION, AND JEFF CAMPBELL, DIRECTOR OF PARKING AND TRANSPORTATION.

PARAGRAPH 7: THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
