A RESOLUTION

TO URGE AND REQUEST INFORMATION SERVICES TO BETTER PROMOTE THE SYLLABUS DATABASE TO STUDENTS AS WELL AS TO MAKE IT MORE EASILY ACCESSIBLE TO STUDENTS BY ADDING A LINK TO THE MYLSU WEBSITE HOMEPAGE

PARAGRAPH 1: WHEREAS, THE SYLLABUS DATABASE WAS AN INITIATIVE LAUNCHED BY PREVIOUS STUDENT GOVERNMENT MEMBERS TO PROVIDE TRANSPARENT AND DETAILED INFORMATION OF LSU COURSES TO STUDENTS; AND

PARAGRAPH 2: WHEREAS, THE SYLLABUS DATABASE IS NOT EASILY ACCESSIBLE OR KNOWN TO MANY STUDENTS; AND

PARAGRAPH 3: WHEREAS, THE SYLLABUS DATABASE IS A CRUCIAL RESOURCES FOR STUDENTS TO GAIN BETTER UNDERSTANDING OF THE EXPECTATIONS AND OBJECTIVES OF COURSES BEFORE SCHEDULING; AND

PARAGRAPH 4: WHEREAS, PROMOTING THE SYLLABUS DATABASE AND POTENTIALLY MAKING IT A FEATURE OF THE MYLSU HOMEPAGE SIDE BAR WOULD SIGNIFICANTLY INCREASE ITS USAGE AND ACCESSIBILITY TO STUDENTS.

PARAGRAPH 5: THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT THE SYLLABUS DATABASE IS THOROUGHLY PROMOTED AND ADDED AS A LINK FOR STUDENTS ON THE MYLSU WEBSITE HOMEPAGE, AND

PARAGRAPH 6: BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO IT COMMUNICATIONS AND PLANNING OFFICER, SHERI THOMPSON; AND ASSOCIATE DIRECTOR, MICHELLE LOWERY.

PARAGRAPH 7: THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
